Financial Transparency

The college has a finance committee appointed by the governing body. It tracks the financial transactions and discusses the matters in their meetings to evolve appropriate strategies to achieve effective and efficient funds management. The finance committee meets twice a year and the report along with audited statements is presented in the Governing Body.

Annual financial auditing is done by the internal auditor who is duly approved by the Governing Body at periodical intervals. A statutory auditor who is duly approved by the Governing Body will complete the process of statutory audit and assure the institution of various compliances. Apart from the regular systems in place for auditing, Regional Joint Director and the office of Joint Director of Collegiate Education carry out the audit on a regular basis. All queries raised by these government bodies are duly clarified; no queries remain pending till date. After the clarifications on the queries raised by the above-stated government offices, the Accounts General of Tamil Nadu Region conducts an audit.

In order to ensure financial transparency, the following system, practices and procedures have been put in place:

1. Enterprise Resource Planning system is used to track the financial status on various payments and receipts.

2. Students can generate their fee challan from the student's portal. It helps the parents and wards to have a complete view of details of the fees.

3. All payments are done only through crossed cheques or account transfers done through NEFT and RTGS.

4. All receipts of funds in the form of contributions, endowments and other sponsors are done only through bank transactions.

5. Concessions, scholarship and any other aid from the college are always done through account transfer.

6. Filing of tax returns is done regularly.

7. All utilization certificates are promptly submitted to the funding agencies concerned, in time with approval from the certified auditor.

- 8. The UGC mandatory PFMS is in place.
- 9. The statement of income and expenditure are presented before the governing body for approval.

Academic Transparency

The student representatives play an active role in the deliberations of the Board of Studies and Academic Council. The college website hosts information about the curriculum, syllabus and rules and regulations pertaining to academic matters. The old question papers of UG and PG programmes are published on the website The softcopy of the students' handbook is uploaded for ready reference. MCQs bank for each course is developed and uploaded on the website and the college has made it mandatory for the faculty to strengthen the MCQs bank at regular intervals. The CIA component marks are entered online by the faculty immediately after the valuation for instant student access. Students are entitled to access their answer papers of summative review as part of the transparency process.

Transparency in administrative and auxiliary functions

The college gives open call through notice board for applications from qualified staff while filling- up the administrative positions such as Deans and Heads of the Department. A centralized and comprehensive recruitment system is in vogue for the appointment of qualified staff to various positions. A comprehensive appraisal system provides for the performance evaluation of the teachers by the administrators, peers, subordinates and students. The outcome of this exercise helps the teachers to enhance their performance. The college has a well-defined grievance handling mechanism to address the grievances of the students and the staff. The management periodically holds meetings with the staff association and student council to solicit their views and share details about the various activities undertaken. Collective decision making is encouraged in the institution whenever important academic and administrative decisions are made. An Open Forum for the students is organised for greater clarity in administrative issues.
